2	Motherland Associates.	As per Terms and Conditions of the Tender clause 1 (a) 1. Eligibility Criteria a. Bidder should have at least 03 years' satisfactory experience of providing Canteens.(Please enclose Proof) The bidder fails to provide 03 year Experience. The Committee rejected the bid of Motherland Associates due to less than three years' experience which was required for the eligibility of the firm/bidder.
3	Zain Traders	Initially Zain Traders was eligible but due to non-verification of experience and satisfactory report Zain Traders becomes ineligible due to less than three years of experience.

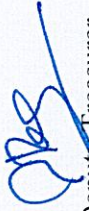

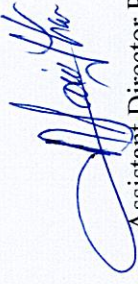
