Bidding documents containing all terms and conditions can be obtained from the office of the Undersigned on payment of Rs. 500/- (Non-Refundable) in the form of Demand Draft/Pay Order/CDR in favour of Women University Swabi on any working day during the office hours upto the above mentioned deadline.
2. The bidding shall be done on “**Above/Below System**” on the BoQ Cost.
3. The Bid Security/Earnest Money must be accompanied with the bids in shape of CDR or Bank Guarantee from Schedule Bank of Pakistan
4. The bidders shall submit their bids on the address “**Deputy Director Works, Women University Swabi, Kotha Swabi**” only through reliable courier service on or before the deadline along with required documents as per details mentioned in the bidding documents.
5. All the bidders are required to have valid registration with Khyber Pakhtunkhwa Revenue Authority.
6. The bidders quoting their bids upto a limit of 10% below on Engineer’s Cost Estimate shall submit Bid Security @ 2% of Engineer’s Cost Estimate. The contractors quoting their bids more than 10% below upto 20% below on Engineer’s Cost Estimate shall submit 8% additional Bid Security in addition to 2% Bid Security. A contractor quoting bid more than 20% below shall submit Additional Bid Security on Engineer’s Cost Estimate equal to differential amount of submitted Bid Cost and Engineer’s Cost Estimate. If a bid is not accompanied by required amount of additional bid security, his bid will be considered non-responsive.
7. If the evaluated bid costs of two or more bidders are equal, then the successful bidder will be decided through draw/toss.
8. The University/Procuring Entity reserves the rights to reject one or all bids as per KPPRA/PPRA Rules.
9. All the Government Notification(s)/Rules/Taxes updated from time to time shall be applicable.
